


### WORKFORCE DEVELOPMENT

Nevada Partners is making strides! To date, Nevada Partners' Workforce Development Division has provided services to **425** residents successfully exceeding the **275** residents projected to receive services for this program year! The special populations we train include **17%** of TANF recipients, and formerly incarcerated individuals among others. Our return on investment has been over **\$9,315,259.20** in earned wages into the Southern Nevada economy.



This effort includes providing training services to **244** job seekers and approximately **\$263,758** in supportive services like transportation assistance, work cards and tools. The result is a powerful return on investment for the community. To date, Nevada Partners has helped **291** residents gain employment, with an average hourly wage of **\$15.39**.








### SUCCESS STORY


Ms. Adebo was previously employed as an accountant, but was laid off November 2012. Ms. Adebo came to Nevada Partners, Inc. on January 25, 2013 seeking financial assistance for training as an accounting office specialist. She had a letter from an employer offering her a job as an accountant and office specialist, contingent receiving certification in the field. Ms. Adebo started working at a home health agency in February of 2013 with a wage of \$10.00 an hour. She began the training as an Accounting Office Specialist on February 12, 2013 and successfully completed the training on May 23, 2013. Ms. Adebo is still employed at the home health agency and is now has a full time position and has received a wage increase earning \$20.00 an hour. Workforce Investment Act services are changing lives!


# **Summer Component/Year Round Grant Enrollments**



## **Summer Component/Year Round Grant Performance Measures**







### **Graduate Advocate Initiative**

Nevada Partners administers the Graduate Advocate Initiative. To date, Nevada Partners' Youth Division has provided services to **478** In School Youth, of the **460** youth participants projected to receive services this program year! Nevada Partners has completed **104**% of the projected enrollments. During the month of June, Nevada Partners provided **\$23,376.46** in support service, a significant increase in client expenditures. To date, over 70% of Graduate Advocate Initiative participants have successfully graduated; exceeding performance measures by 14%.


## **Graduate Advocate Initiative Enrollments**



### **SUCCESS STORY**

Ms. Schersel graduated from Rancho High School and has been a part of Communities in School and Workforce Investment Program since October 2012. She was enrolled in the magnet program, specializing in Medicine and wanted to pursue her dream to attend Southern Utah University and continue onto University of California, Los Angeles for medical school. While struggling with the demands of home, culture, religion, and school, student was not sure whether she would receive acceptance due to her falling behind in school with a low GPA. Education is not a high value at home, and rather student is encouraged to work than go to school. After much conversation regarding applying to schools, her graduate advocate counselor encouraged Ms. Schersel to call the admissions office to inquire regarding the requirements for admissions. After speaking to the admissions office, student submitted an application and short after received an acceptance letter. Workforce Investment Act youth services are changing lives!
